Groundwater's Role in Mississippi's Economic Vitality

- Few states can accurately or confidently determine how many residential wells are in place. For each region, the American Housing Survey by the U.S. Census provides regional data. The South region includes the states of Maryland, Delaware, Virginia, North Carolina, South Carolina, Georgia, Florida, Alabama, Mississippi, Texas, Oklahoma, Arkansas, Tennessee, and Kentucky. The last American Housing Survey indicates this region had 4,360,000¹ households served by residential wells, with an average of 2.66² persons per household. The U.S. Census stopped asking citizens their source of water supply following the 1990 Census. The USGS estimates the population of self-supplied water supply users in Mississippi to be 446,000³.
- 1,050 community water systems use groundwater for 2,840,000 people⁴.
- 69 non-community, non-transient water systems use groundwater for 54,800 people⁴.
- 75 non-community, transient water systems use groundwater for 11,700 people⁴.
- 14,700 irrigation wells are in use serving 1,450 farms and 1,610,000 acres⁵.

Mississippi's Groundwater Industry Employment

Men and women working to provide and protect Mississippi's groundwater resources for the benefit of people, business, and our environment.

Mississippi's Contracting Employment

Drill and service water wells, install and service pumps, install and service point-of-use water treatment devices. This portion of the industry is characterized by small firms, many of which are multi-generation family-owned and operated.

- 57 firms employ an estimated 439 people⁶
- Annual estimated sales of \$110 million⁶

Mississippi's Scientists and Engineers Employment

Geologists, hydrogeologists, engineers, geochemists, geophysicists, microbiologists, regulators.

Environmental Consulting⁷

NAICS 54162: Establishments primarily engaged in providing advice and assistance on environmental issues, such as the control of environmental contamination from pollutants, toxic substances, and hazardous materials.

- 94 firms employ an estimated 283 people
- Annual estimated sales of \$41.4 million

Remediation⁸

NAICS 56291: Establishments include those engaged in remediation and cleanup of contaminated buildings, mine sites, soil, or groundwater.

- 46 firms employ an estimated 424 people
- Annual estimated sales of \$59.5 million
