## Groundwater's Role in Connecticut's Economic Vitality

- Few states can accurately or confidentially determine how many residential wells are in place. For each region, the American Housing Survey by the U.S. Census provides regional data. Connecticut is found in the Northeast, along with these other states: Maine, Vermont, New Hampshire, Massachusetts, Connecticut, Rhode Island, New York, New Jersey, and Pennsylvania. The last American Housing Survey Census indicates this region had 3,210,000<sup>2</sup> households served by residential wells, with an average of 2.6<sup>3</sup> persons per household. The U.S. Census stopped asking citizens their source of water supply following the 1990 Census. The USGS estimates the population of self-supplied water supply users in Connecticut to be 871,000<sup>4</sup>.
- 456 community water systems use groundwater for 285,000 people<sup>5</sup>
- 533 non-community, non-transient water systems use groundwater for 107,000 people<sup>6</sup>
- 1,440 non-community, transient water systems use groundwater for 58,300 people<sup>7</sup>
- 582 irrigation wells used serving 459 farms and 2,030 acres<sup>8</sup>

# Connecticut's Groundwater Industry Employment

Men and women working to provide and protect Connecticut's groundwater resources for the benefit of people, business, and our environment.

## Connecticut's Contracting Employment

Drill and service water wells, install and service pumps, install and service point of use water treatment devices. This portion of the industry is characterized by small firms, many of which are multi-generation family-owned and operated.<sup>9</sup>

- 41 firms employ an estimated 253 people<sup>10</sup>
- Annual estimated sales of \$76.2 million

## Connecticut's Scientists and Engineers Employment

Geologists, hydrogeologists, engineers, geochemists, geophysicists, microbiologists, regulators.

### Environmental Consulting<sup>11</sup>

NAICS 54162: Establishments primarily engaged in providing advice and assistance on environmental issues, such as the control of environmental contamination from pollutants, toxic substances, and hazardous materials.

- 350 firms employ an estimated 1,120 people
- Annual estimated sales of \$162 million

### Remediation<sup>12</sup>

NAICS 56291: Establishments include those engaged in remediation and cleanup of contaminated buildings, mine sites, soil, or groundwater.

- 106 firms employ an estimated 1,820 people
- Annual estimated sales of \$343 million

### Public Service and Universities, Colleges, and Research Centers

- Many more dedicated individuals
